A Regular Meeting of the Grand Saline Public Library Advisory Board will be held on May 1, 2024 at the Grand Saline Public Library, 201 NE Pacific Street, Grand Saline, TX

Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the Public Participation section of the meeting or at the time the agenda item is called for discussion by the chair of the Public Library Advisory Board. Speakers shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of Public Library staff shall be allowed, but only after all administrative remedies have been exhausted regarding any such complaint giving rise to the criticism. Those wishing to address the board regarding an item not on the agenda must be a citizen, property owner, or business owner in Grand Saline. Comments on such non-agenda items shall be limited to three (3) minutes. The board will not comment on items not on the agenda; however, the board may refer the item to library staff for research, resolution, or referral of the matter to the board as a future agenda item.
